Required for Credit Approval:

- **A minimum of 6-9 months of business bank statements**
 - The 5-8 oldest months, must be on bank forms (not transactional history print outs);
 - The most current month, may be printed from online banking;
 - The bank account MUST be in the name of the applicant/business

- **2 pieces of ID for each shareholder (one must be a government issued ID with a picture)**
 - Front and back of each piece of ID is required
 - Driving License + SIN/Passport/PR Card etc.
 - Selfie ID photo might be required if asked by the lender (photo of yourselves holding up a piece of ID(Driving License) so that it can be compared to your face and it is legible).

Required to Fund your Loan:
